The Orwigsburg Borough Council met on Wednesday, September 12, 2018 in Council Chambers. President Michele Rudloff called the meeting to order at 7:30 pm and the Pledge of Allegiance was recited.

Bill Knecht of 204 S. Warren St asked if there was a significant renovation - Cigar Box renovation \$75,000

Veterans Community Memorial Hall

The Borough was notified yesterday that our RACP grant for \$750,000.00 was approved. Grant is to complete renovations at the Veterans Community Memorial Hall. Thanks to Rep. Jerry Knowles, Rep. Neil Goodman, Rep. Mike Tobash, Senator Dave Argall and Governor Tom Wolf. Approval of this grant was truly a collaborative team effort. Grant is a draw down process – money expended then reimbursed. Master plan will need to be submitted again. A match was required, the building's equity was used for the match.

Public Comment #1 Agenda Items Only

Athena Kukta of 345 Ridge Rd – last month she addressed Council about 24/7 police coverage. Twice she had someone knock on her door at 1 am. Both times there was no police officer on duty. The first incident the state police didn't show up but they did call her. The second time the State Police did show up. It was determined she was a victim of a computer crime. She has since installed cameras around her house along with an alarm system. She thanked the Orwigsburg Police Dept for their support. She is present tonight to see where the Borough stands with hiring an additional officer.

Council did approve the Civil Service Commission to establish a candidate list. Application were due by September 7th. Civil Service meets on September 27th, a date will be set for the written exam, then the agility test followed by oral interviews. Next month begins the budget process which will be driving a lot of the discussion.

Chief Koury stated our goal is to have a true 24/7 department. People have told the department they want 24/7 police coverage.

Kay Jones of 110 W Market St pointed out they spent all last summer and fall on the Great Orwigsburg survey and 66% of the people that responded felt that borough council should assure 24/7 police protection through a tax increase. That is the people speaking to you (Council).

Sue – how many 377 people responded

Bill Knecht 204 S Warren St in the interim until there can be 24/7 coverage consider assuring overnight hours are covered opposed to having daytime coverage. Since overnight hours are the worst time for the safety of our residents.

Chief Koury – we are busy during the day if not busier, we cannot eliminate coverage during the daytime hours. There are two schools to consider with 1200 children. Twenty-one years ago DCED did a survey and the results were in order to run a 24/7 department you need 6 officers and a Chief. I have been scheduling overtime to cover night shift hours.

Bill Knecht asked if the other parties signed off on the Sopko agreement? Solicitor Datte responded yes it happened this evening.

When all the documents have been completed will they be available to the public? Yes, submit a Right to Know request.

Old Business

Solicitors Report - Paul Datte

- 1. Pine Creek Retirement Community he reported last month that briefs have been filed. Rhodes Organization is moving the matters forward. Rhodes requested oral argument before the judge but has not been scheduled yet.
- 2. Blue Mountain Retirement Community Appeal from the Zoning Hearing Board. briefs have been filed for over a year. Rhodes Organization has requested oral argument in front of a judge. Rhoads Organization requested oral argument and will be heard by Judge Domalakas on September 26th.

The Rhodes Organization has challenged the engineering fees of the borough in respect to reviewing both plans, they have requested arbitration under the Municipalities Planning Code (MPC). Need to select an engineer as an arbitrator, our engineer recommended Great Valley Associates located in Wyomissing. Recommendation has been conveyed to the Rhodes Organization but haven't heard anything back.

- 3. Villas of Orwigsburg case is sitting will move forward when the developer decides to do so. Position of the borough remains unchanged until there is a further order from the courts.
- 4. Sopko/SCMA Cases have to be discontinued by the attorneys. Easement document needs to be recorded. Principal settlement and payment will be wrapped up within the next few days.

Police Department Report

The August 2018 Police Report is attached to minutes.

Chief Koury noted I do support a 24/7 professional Police Department like the people have told the Borough they want. Its up to council to listen to the people and what they want. We need trained professionals 24/7. I don't see people here against raising taxes. Elected officials need to do what the people want.

President Rudloff responded Council needs to make decisions about streets, storm water systems that are failing; aging water and sewer system; not just a decision about police. There have been numerous residents contacting the borough about flooding and the condition of their streets. We cannot continue to allow systems to malfunction and do nothing about it. We're at a crossroad with tuff decisions to make. Multiple issues need to be addressed in this budget; what can the police department do to meet Council ½ way.

Budget committee will be meeting in the near future.

Rod Schaeffer mentioned back in April's meeting Matt Baran from the Authority suggested raising the sewer rate \$7.00 per quarter to be used for capital improvements. Keep this in mind during the budget process.

Angie Hoptak-Solga asked Council to consider increasing the annual Senior Citizens donation from \$750.00 to \$1,000.00.

Bob noted he spoke with the President of the Senior Citizens and they will be meeting at Memorial Bldg. on Tuesdays at no charge and line item for their donation will be increased to \$1000.00.

Public Comment #2

Taunia Gerber of 1015 Ridgeview Dr asked what the cost is for OT compared to the cost of another officer. She is not against a tax increase if she sees services in return.

Costs about \$100,000 for another officer, Overtime is not nearly that much.

Councilor Bedway noted when the Ridgeview Development went in the borough received a lot of revenue. There hasn't been any development like that since.

Bill Knecht of 204 S Warren St asked who are the member of the Budget Committee? Councilors Paul Bedway, Brian Baldwin and Rod Schaeffer

Carol Lutsey of 335 Ridge Rd asked if the borough would make money from the Retirement Community.

Solicitor Datte responded no necessarily, it would depend on how the development would be

structured. If it is owned units then we would receive transfer tax when ownership would change but if leased units the borough wouldn't receive anything. If divided into lots and developed we would receive transfer tax, EIT tax. If limited to retired seniors than no EIT tax.

Anthea Kukta of 345 Ridge Rd asked if we ever considered regionalizing the Police Department – Michele responded the conversation has occurred, the municipalities would not be willing to put costs behind it. They have no cost now being covered by State Police.

There being no further business the meeting was adjourned at 8:35 pm.
